The following terms and conditions are applicable without prejudice.

Hauptstelle für das Grubenrettungs- und Gasschutzwesen Austria – HGGW (Austrian Body for Mine Rescue and Gas Defence) operates this website and the IMRB 2025 Conference. Throughout the site, the terms "HGGW", "we", "us" and "our" refer to Hauptstelle für das Grubenrettungs- und Gasschutzwesen Austria where appropriate. HGGW offers this website, including all information, tools, and services available from this site to you, the user, conditionally upon your acceptance of all terms, conditions, policies, and notices stated here.

- 1.4 Although HGGW will venture to only provide hyperlinks to credible external websites where appropriate, HGGW cannot be held liable and does not accept any accountability for the information, links, content, etc. available and expressed on any of these websites and/or hyperlinks.
- 1.5 The unauthorized use of photographic and recording equipment and recordings including photographs and videos at the Conference are prohibited. No photographs and recordings may be taken without the explicit pre-approval of HGGW, and you may be held liable should you

- take unauthorized photos or recordings. HGGW do not accept any liability for transgressions in this respect by any user, delegate or third parties at the IMRB 2025 Conference.

SECTION 11 - TERMS OF REGISTRATION AND PAYMENT

- 11.1 All Pricing (in Euro) includes Value Added Tax (Umsatzsteuer) at the prevailing statutory rate in line with current Austrian tax legislation requirements.
- 11.2 The pricing of Local (Austian residents) and International (delegates with place of normal residence outside Austria) delegates are different due to inherent cost composition differences (i.e. logistics, transport, accommodation etc.).
- 11.3 HGGW reserves the right to refuse registration and entry for individuals fraudulently and/or in error reporting their place of normal residency as this affects the cost composition.
- 11.4 A tax invoice will be generated for all registered delegates and will be emailed to the email address you provided.
- 11.5 Confirmation of registration as a delegate to the conference will be provided via email to you only once full payment is reflected in the designated bank account.
- 11.6 The onus is upon each delegate to ensure that he/she completes his/her personal information correctly, completely and honestly as this will affect your reservations with the various subcontracted suppliers.
- 11.7 Proof of payment and identification will be required for all delegates.
- 11.8 Once registered and payment is made refunds will only be permitted as detailed in the table below but HGGW reserves the right to amend or change this at any stage for any reason. Date of receipt at Mines Rescue Service: Refund upon written cancellation:
